The 4 modified/combined applications (1-10609, 1-10612, 1-10613 & 21-13160) of the 8 remaining active applications in 2013 were readvertised. Protestants of applications associated with the readvertised applications were sent a letter requiring them to reconfirm their interest in their original protests by timely written notification. No response eliminated them from the protested matter for the newly advertised applications. - Right 1-10609 was readvertised and no confirmation of interest was received from US Fish & Wildlife Services or Fred & Betty Kippes. The 4 unmodified applications (1-7142, 21-7577, 21-7578 & 21-7580) of the remaining 8 active applications in 2013 were not readvertised & protestants were not required to submit confirmation of continued interest in the application. - Right 1-7142 was not readvertised and US Fish & Wildlife Services remains an active protestant. ps 6-1-2017
