## **Conditions Applicable to All Leased Water Rights**

- 1. The water rights referenced above will be rented from the bank at the current rental rate.
- 2. There is no rental payment to the lessor of the water right if the right or a part thereof is not rented from the bank.
- 3. While a right is in the bank, the lessor may <u>not</u> use the right without approval of the Department, even if the right is not rented from the bank. Any violation of the terms of this lease may result in enforcement procedures pursuant to Idaho Code § 42-351 for illegal diversion and use of water and may include civil penalties pursuant to Idaho Code § 42-1701B.
- 4. A right accepted into the bank stays in the bank until the Board releases it, or the lease term expires. A right may be released from the bank upon request, provided the Board approves the release. Unless approved by the Department, leased rights may not be immediately available for release.
- 5. While a water right is in the bank, forfeiture provisions are stayed pursuant to Idaho Code § 42-223(5).


- 6. Rental of water under this right is subject to the limitations and conditions of approval of the water right.
- 7. Failure of the right holder to comply with the conditions of acceptance is cause for the Director to rescind acceptance of the lease.
- 8. Acceptance of a right into the bank does not, in itself, confirm the validity of the right or any elements of the water right, nor does it improve the status of the right or accomplish the resumption of use. It does not preclude the opportunity for review of the validity of this water right in any other Department application process.
- In accordance with Idaho Code §§ 42-248 and 42-1409(6), all owners of water rights are required to notify the Department of any changes in mailing address or change in ownership of all or part of a water right. Notice must be provided within 120 days of the change.
- 10. If a water right leased into the Water Supply Bank is sold or conveyed during the lease term, and if the leased right was rented, the rental proceeds will be disbursed in the following manner regardless of any arrangements between the buyer(s) and seller(s) to the contrary:
  - Rental payments will go to the lessor(s) of record at the beginning of the rental season, even
    if the Department processes a Notice of Change in Water Right Ownership during the rental
    season.
  - b. New lessor(s) of record will receive payment after the following rental season.
- 11. The water rights leased to the bank are subject to all prior water rights and shall be administered in accordance with Idaho law and applicable rules of the Department of Water Resources.
- 12. Use of water under this right is regulated by a watermaster with responsibility for the distribution of water among appropriators within a water district. At the time of this approval, this water right is within State Water District No. 130.
- 13. Unleased portions of rights 37-793, 37-7216 and 37-21721 are limited to irrigation of a combined total of 78.6 acres in a single irrigation season and a total combined diversion rate of 4.157 cfs,
- 14. Point of diversion sources for water rights 37-793 and 37-21721 are also known as Montana Mining company Ditch Spring No.9, Montana Mining Company Ditch Spring No. 10 and Montana Mining Company Ditch spring No. 11.
- 15. Water right 37-7216 has two points of diversion located in the NWNW, S17, T6S, R13E.
- 16. Source in T06S, R13E, S17, NENWNW for water right 37-7216 is also known as Montana Mining Company Ditch spring No.11.
- 17. In the event of a call in times of scarcity, the diversion of water for water rights 37-793 and 37-21721 from the point of diversion located in T06S, R13E, S17, NESESE (also known as Montana Mining Company Spring No. 9) is junior to the diversion of water from the same spring for water rights 37-7218 and 37-21222.
- 18. The use of water for irrigation under water right 37-7216 may begin as early as March 15 and may no continue to as late as November 15, provided other elements of the right are not exceeded. The use of water before April 1 and after November 1 under this remark is subordinate to all water rights having no subordinated early or late irrigation use and priority date earlier than the date a partial decree is entered for this right.
- 19. The unleased fish propagation use of 37-7216 is limited to a diversion rate of 3.63 cfs in a single season.
- 20. The unleased irrigation use of 37-7216 is limited to a total diversion rate of 2.17 cfs and a total diversion volume of 325.5 af in a single irrigation season.



To release the right from the Bank prior to the release date, submit a written request on the <u>Request to Release a Water Right from the Bank</u> form. To propose a new lease period, submit a new <u>Application to Sell or Lease a Water Right to the Water Supply Bank</u> form along with applicable fees to the Department. These forms are available from any IDWR office or from our public website at <a href="http://www.idwr.idaho.gov">http://www.idwr.idaho.gov</a>. Please note your rights may not be available for immediate release if they have been rented.

Please review the conditions of acceptance listed on the Lease Contract, including #3 which says: "While a right is in the bank, **the lessor may not use the right** without approval of the department even if the right is not rented from the bank.
