**SHEKINAH’S AND NEVID’S
STIPULATION TO DEFER THE
SUBORDINATION ISSUE**

Shekinah Industries and D. Michael Preston (together “Shekinah”), and Nevid LLC (“Nevid”), through their respective attorneys, hereby stipulate and agree that the following issue need not be addressed in the above-captioned consolidated proceeding:

Where a point of diversion is proposed to be transferred to a new location (as is proposed in Shekinah's transfer application), whether it is appropriate to subordinate the transferred right to rights with points of diversion already established near the new location.

This issue, and others that may be subsumed within or related to it, are purely legal questions raised only by Nevid in its protest of Shekinah's transfer application. This issue is not germane to this consolidated proceeding, the purpose of which is to "conduct[] a hearing regarding the limited issue of the sufficiency of the ground water supply." *Order Creating Contested Case and Consolidating Protested and Unprotested Applications* at 5 (Jan. 24, 2012).

Accordingly, Shekinah and Nevid stipulate and agree to defer addressing the issue described above, including any briefing and argument, to the individual contested case in Transfer 73811, and that neither party shall be prejudiced by failing to file a dispositive motion on the issue in this consolidated proceeding before the March 31, 2013 deadline set forth in the Director's April 13, 2012 *Prehearing Scheduling Order*.


