PLEASE TAKE NOTICE that the ongoing hearing for the M-3 Eagle contested case will be resumed on **June 23, 2009, beginning at 9:00 a.m.** at the offices of the Idaho Department of Water Resources (“Department”), located at 322 East Front Street, 6th Floor Conference Rooms, Boise, Idaho. The presiding officer at the hearing will be Gary Spackman. Attached is a previously issued notice of hearing sent to the participating parties scheduling June 23, 2009 and three other days in July for presentation of additional evidence.

Many persons who originally protested the M-3 Eagle application designated a spokesperson for presentation of evidence at the hearing. The hearing officer ordered that protestants who designated a spokesperson could participate in the hearing as public witnesses. Public witnesses can attend the hearing and present their own testimony and evidence.

On June 23, 2009, beginning at approximately 1:00 pm in the afternoon, you may appear and testify at the hearing. Again, the hearing will be conducted at the offices of the Idaho Department of Water Resources (“Department”), located at 322 East Front Street, 6th Floor Conference Rooms, Boise, Idaho. You may park your vehicle in the parking garages that underlies the Department offices. There is a fee for parking. Enter the parking area on South Avenue A, which is located on the east side of the Winco parking lot.

Witnesses should present facts about which they are personally acquainted. The testimony must be limited to the factors listed on the attachment to this document. Testimony of opposition to or support of the project without a presentation of facts supporting the statement will be considered repetitive, cumulative testimony. Because of the filing of a protest, the hearing officer is already aware of the opposition, and is interested in facts supporting the position of the witness. The hearing officer will limit the presentation of bare statements of cumulative opposition or support.

After assessing the number of public witnesses that appear, the hearing officer may establish a time limit for presentation by each public witness.

If you plan to offer exhibits for the record at the hearing, note that Rule 606 of the department's Rules of Procedure requires that a copy be provided to each party and to the presiding officer.

The hearing will be held in accordance with the provisions of Chapters 2 and 17, Title 42 and Chapter 52, Title 67, Idaho Code, and the adopted Rules of Procedure of the department. IDAPA 37.01.01. A copy of the rules may be obtained from the department upon request.

The hearing will be conducted in accordance with the accessibility requirements of the Americans with Disabilities Act. If you require special accommodations in order to attend, participate in or understand the hearing, please advise the department no later than five (5) days prior to the hearing. 

**PROCEDURES FOR PUBLIC WITNESSES
FOR A PROTESTED APPLICATION FOR PERMIT**

ISSUES

Applications to appropriate the water of the state of Idaho are referred to as applications for permit, and are for the development of new water rights. Section 42-203A, Idaho Code, requires the department to consider the following issues in connection with an application for permit:

1. Will the proposed appropriation reduce the quantity of water under existing water rights?
2. Is the water supply sufficient for the purpose for which it is sought to be appropriated?
3. Was the application made in good faith or for delay or speculative purposes?
4. Does the applicant have sufficient financial resources with which to complete the proposed project?
5. Will the proposed use conflict with the local public interest, where local public interest is defined as interests that the people in the area directly affected by a proposed water use have in the effects of such use on the public water resource?
6. Will the proposed use be contrary to the conservation of water resources within the State of Idaho?
7. Will the proposed use adversely affect the local economy of the watershed or local area within which the source of water for the proposed use originates, in the case where the place of use is outside of the watershed or local area where the source of water originates?

EXHIBITS

A party who plans to offer an exhibit as part of the hearing record must provide a copy of the proposed exhibit to the parties and to the hearing officer.

AMERICANS WITH DISABILITIES ACT
