Conditions of Approval:

- 1. 133 This right authorizes the diversion of ground water within the Rathdrum Prairie Ground Water Management Area (RPGWMA). Use of water under this right shall be subject to the provisions of any management plan approved by the director for the RPGWMA. If the director determines that the ground water supply in the RPGWMA is insufficient to meet the demands of prior water rights within the RPGWMA, the director may order the diversion and use of water under this right to be reduced or curtailed until the director determines that there is sufficient ground water available for this right.
- 2. 132 Domestic use is for 9 homes. Irrigation of lawn, garden and landscaping associated with the homes is authorized under the irrigation component of this right.
- 3 R66 This right when combined with all other rights shall provide no more than 0.03 cfs per acre nor more than 3.0 afa per acre at the field headgate for irrigation of the lands above.

Comment: While reviewing this file for licensing, I found the following worth noting: Some of the properties have changed ownership since the field exam was done.

Neither the POD nor the POU shapes had been created prior to my review. I created them based on the field exam notes and map and a combination of 2004 and 2006 NAIP aerial photography.

POD is an existing domestic well. This water right is to accommodate distribution to an additional 8 residences. In total, 9 residences are now being serviced by this well.

The irrigation season of use has not been listed correctly in either the permit or the field exam. The correct season should be 4/1 to 10/31.
