**CONDITIONS OF ACCEPTANCE**

- 1 A portion of the water right referenced above is accepted into the bank and rented in accordance with a private agreement formulated between the lessor and the renter. The total rental fee for leased water right is \$2,055.56 per year based on a negotiated rate through the Columbia River Basin Water Transaction Program.
- 2 Payment for rental of the referenced right from the bank is contingent upon the determination the lessor is in compliance with an executed rental agreement.

**CONDITIONS OF ACCEPTANCE**

3. During the term of the lease, irrigation of the place of use described above is not authorized under water rights 75-4199 or 75-4200, and the lessor may not irrigate the associated place of use with water from any other source.
4. While a right is in the bank, the owner of the right may not use the right without approval of the department even if the right is not rented from the bank. Any violation of the terms of this lease may result in enforcement procedures pursuant to Section 42-351, Idaho Code, for illegal diversion and use of water, and may include civil penalties pursuant to Section 42-1701B, Idaho Code.
5. A right accepted into the bank stays in the bank until the Board releases it, the lease term expires, or upon request from the lessor to change the term of the lease.
6. While a water right is in the bank, forfeiture provisions are stayed.
7. Rental of water under this right is subject to the limitations and conditions of approval of the water right.
8. Failure of the right holder to comply with the conditions of acceptance is cause for the Director to rescind acceptance of the lease.
9. Acceptance of a right into the bank does not, in itself, confirm the validity of the right or any elements of the water right, or improve the status of the right including the notion of resumption of use. It does not preclude the opportunity for review of the validity of this water right in the ongoing Snake River Basin Adjudication or any other department application process.
10. In accordance with Sections 42-248 and 42-1409(6), Idaho Code, all owners of water rights are required to notify the department of any changes in mailing address or change in ownership of all or part of a water right. Notice must be provided within 120 days of the change.
11. Upon acceptance of a water right into the Board's water supply bank, the owner of the right may withdraw the right within thirty (30) days of acceptance into the bank if the owner does not agree with the conditions of acceptance.

The water right(s) is leased to the bank subject to all prior water rights and shall be administered in accordance with Idaho law and applicable rules of the Department of Water Resources.
