Re: Permit 63-32067, Condition of Approval for Bypass Flow in Creek

Dear Mr. Leitzinger:

This letter concerns a permit approved by the Idaho Department of Water Resources (IDWR) in September 2005 for winter use of water from Sand Hollow Creek (aka Sand Run Gulch etc.). Permit No. 63-32067 authorizes up to 90 cfs for wildlife habitat as noted in the other information provided to you simultaneous with this letter.

The above permit potentially allows the creek to be totally dewatered for about $\frac{1}{4}$ to $\frac{1}{2}$ mile on the permit holder's property. IDWR assumes return flows to the creek would continue whenever water is diverted from the creek for the project. Dewatering of the creek would therefore be limited to an area just south of Highway 20/26 and just east of Highway 95.

Condition of Approval No. 5 in the permit states the following:

The Director retains jurisdiction to require a bypass flow on Sand Run Gulch Creek for maintenance of fish, wildlife, riparian and aquatic habitat.

IDWR received a petition asking the Director to invoke Condition No. 5 for this permit. The petitioner did not provide technical information to support the petition. I hope your agency can advise IDWR in this matter as noted by the following questions:

1. Should IDWR require some water to remain in the creek when Permit 63-32067 is being used?
2. If so, for what reasons should this be required? What habitat benefits would be realized by invoking this condition of approval?
3. What is the minimum rate of flow needed in the creek to protect those habitat benefits?


