

On November 10, 2005, the Idaho Department of Water Resources (IDWR) filed its *Director's Report, Part 1, For Reporting Area 11 (Basin 27)*, which included recommendations for the above-captioned water rights. On January 11, 2006, IDWR filed amended director's reports for the above-captioned water right claims in order to correct clerical errors and/or omissions. No objections to the original or the amended recommendations were filed and the time period for filing objections has now expired. On March 20, 2007, a hearing was held on these uncontested water right claims pursuant to I.C. § 42-1412(7). No party appeared in opposition to any of the amended recommendations.

Therefore, IT IS ORDERED that the above-captioned water right claims are hereby **decreed** as set forth in the attached *Partial Decree Pursuant to I.R.C.P. 54(b)*.
