
On January 20, 2005, the Idaho Department of Water Resources filed its *Director's Report for Irrigation & Other, Reporting Area 22 IDWR Basin 85* recommending that the water right claims listed on Exhibit A be dismissed. THEREFORE IT IS ORDERED AND ADJUDGED that the water right claims listed on Exhibit A are hereby **disallowed with prejudice** and shall not be confirmed in any partial decree or in any final decree entered in the SRBA, Case No. 39576, in whatever form that final decree may take or be styled.
