On May 10, 2001, the Director of the Idaho Department of Water Resources filed a *Director's Report for Irrigation and Other Water Rights (IDWR Basin 31)*, recommending that the water right claims listed on the attached Exhibit A be **disallowed.** The time period for objecting to this recommendation has passed.

As this Court has previously determined, all claims reported to the Court by the Director of IDWR shall appear in a decree. This is required so that there is no confusion over action taken by the Court on all claims reported to it.

THEREFORE IT IS ORDERED AND ADJUDGED that the water right claims listed in Exhibit A are hereby **disallowed with prejudice** and shall not be confirmed in any partial decree or in any final decree entered in the SRBA, Case No. 39576, in whatever form that final decree may take or be styled.
