

CONDITIONS OF APPROVAL

A measuring device of a type approved by this Department shall be permanently installed and maintained as part of the diverting works.
Measuring devices of a type approved by this Department shall be permanently installed and maintained at the point of diversion and the point of effluent discharge.
Use of water under this permit is supplemental to all existing water rights with the same purpose and place of use.
Maximum rate of diversion shall not exceed c.f.s.
Settling ponds shall be installed which are capable of reducing the silt load in the return water to such a level that the quality of the waters of Creek will not be impaired for other beneficial uses.
Return water shall be treated to insure that the effluent meets (interstate) (intrastate) stream water quality standards.
Use of water under this permit is subject to control by the watermaster of State Water District No
The proposed well shall not be drilled within feet of another well.
The issuance of this permit in no way grants any right-of-way or easement across the land of another person.
The permit shall not be assigned or sold without first securing the written approval of the Department of Water Administration.
This permit cannot be assigned, mortgaged, or conveyed without complying with Section 42-208, <u>Idaho Code</u> .


