CHANGE TO WATER RIGHTS**

Notice is hereby given that an Application for Transfer has been filed with the Idaho Department of Water Resources for changes to water rights within Jerome County: **A & B IRRIGATION DISTRICT, PO BOX 675; RUPERT ID 83350-0675** filed Application No. 71659 on 10/13/2004. Transfer application proposes adding an existing well to a system presently consisting of 185 wells. The system is covered by 12 water rights that total 1100 cfs for irrigation of 66,686.2 acres. The new well being added is located approximately 4.25 miles north and 7.25 miles east of Hazelton. The well is being added to maintain overall production capacity of the A & B Irrigation District system.
