83318 filed Application No. 71593 on 10/25/04. Transfer proposes changing the place of use of seven ground-water rights appurtenant to a farm located approximately 9.5 - 12.5 miles north and 7.0 - 8.5 miles east of Malta to allow for the movement of a pivot location from the south end of the farm, to an area just north of the farm (approximately 13.0 miles north and 7.75 miles east of Malta). In total, the seven rights will divert 19.44 cfs from four existing wells on the farm for the irrigation of an 1170-acre permissible place of use.
