T19 Pursuant to Section 42-1412(6), Idaho Code, this water right is subject to such general provisions necessary for the definition of the rights or for the efficient administration of water rights as may be determined by the Snake River Basin Adjudication court at a point in time no later than the entry of the final unified decree.

5. X27 This right is limited to the irrigation of 8.7 acres within the place of use described above in a single irrigation season.
6. X35 Rights 36-16186, 36-16190 and 36-16194 when combined shall not exceed a total diversion rate of 0.18 cfs, a total annual maximum diversion volume of 64 af at the field headgate, and the irrigation of 16 acres.
7. X36 Rights 36-16184 thru 36-16195, 36-16104, 36-16106, and 36-16108 are all diverted through the point(s) of diversion described above.
8. X61 The period of use for the irrigation described in this approval may be extended to an ending date of 11/15 provided that beneficial use of the water can be shown and other elements of the right are not exceeded. The use of water after 10/31 is subordinate to all water rights having no subordinated early or late irrigation use and a priority date earlier than the date of the originating approval/SRBA partial decree date.
