RE: Bear River Measuring Device order in State Water District 11

Dear Mr. Alleman,

The Idaho Department of Water Resources (IDWR) is in receipt of your correspondence dated March 17, 2008 related to measuring device requirements on your diversion located in Water District 11, Bear River.

In your letter you propose to install a mechanical type meter for your diversion. This letter is to inform you that mechanical type flow meters are not acceptable for new meter installations under IDWR's order issued February 20, 2008 for Bear River water users pertaining to flow measurement devices. This order was based on the Department's newly accepted minimum standards for flow meters of Magnetic type.

Magnetic type flow meters are installed much like mechanical meters but do not have any moving parts that tend to wear and require more attention to maintenance (mechanical meters do not deal well with debris including sand and moss that is generally pumped from a surface water source). Magnetic meters can be installed in much shorter straight runs of pipe and still meet the accuracy requirements outlined in the Minimum Acceptable Standards document written and accepted by the Department. The Departments acceptance of new Magnetic type flow meter standards will provide water users a more reliable and cost effective approach to meeting the requirements of measurement.

Please re-submit your plan for meeting the requirements of water measurement outlined in the Order dated February 20, 2008 for your diversion by May 15, 2008. I have attached the minimum acceptable standards for flow meters to aid you in your decision.

The change in ownership you refer to in your letter is done by filling out the proper paper work showing the new ownership of the water right. This is not automatically done by IDWR; the new owner is responsible to notify IDWR (within 120 days of the change) of a change in the water right ownership. This is done by filing a Notice of Change in Water Right Ownership form along with the appropriate fees and documentation (i.e. warranty deed showing ownership of the property).
