Steve moved, seconded by Darrell, we have the same way of billing for our water district and by special assessment as we have in the past. Motion carried. This means the County Treasurer sends out our bills, collects our bills, and places the monies in our district checking account for our Treasurer to disburse as needed. We will send out resolution (B) and the motion on lockable headgates with the bills. We also need to leave a copy of our minutes with the County Clerk's Office letting him know what we want. He also needs a letter from us asking him to put the monies collected into our checking account at West One Bank in Council.

Our water district made a motion to be put in our by-laws that we use resolution (B) "Resolved: That no ditch, canal company, or other wateruser shall have the right to demand and receive any water, and the watermaster shall not deliver to such person until the amount due and payable from such user, as fixed by the budget, has been paid". This is to be paid by July 1. We also made another motion "Be it resolved that any new diversions being installed in Goose Creek, and all old diversions being modified or rebuilt after March 7, 1994, shall have a delivery device capable of being locked. The secretary shall send out a notice to this effect before the current irrigation season begins".

Please have your headgates and weirs in good condition as it is your water you will be losing. Make sure your bills are paid soon.
