

WATER DISTRICT 13 A MINUTES MARCH 3, 2003

PRESENT: TROY FOSTER, MARVIN SPATIG, PAUL DURSTELER, GLENN & MRS BOWMAN, WALT ROSS, GALE MOSER, BRIAN JENSEN, MAXINE WADDOUPS, CARL SWAINSTON.

Carl Swainston explained what this meeting was about.

Carl Swainston was nominated Chairman; it was moved, 2nd and passed. Maxine was nominated Secretary it was moved 2nd and passed.

Credentials committee was appointed as Brian Jensen and Walt Ross.

Troy Fosters duties as Watermaster was explained and how he comes up with the Budget, etc.

Troy presented the Budget; it is basically the same as last year and how it is averaged over a 5-year period. There is a minimum charge of \$25.00 no matter how small the right. Motion was made to accept the Proposed Budget as Troy had presented it. It was 2nd and passed. Troy was asked if compensation was adequate, and he said he felt okay about it.

The County Clerk collects the assessments.

Motion was made to hire Troy Foster as Watermaster on a Year Round Basis at the Salary presented, it was 2nd and passed. Conan Foster was nominated as assistant Watermaster on a year round basis. It was 2nd and passed.


Advisory committee was appointed as Marv Spatig, and Gale Moser. Treasurer was nominated as Maxine Waddoups, it was 2nd and passed.

Minutes were read and approved from 2002 meeting.

It was noted City Meters were not installed. The problem is supposed to be being resolved. Hopefully get installed this year.

Discussed some problems that Spatigs and Bowmans brought up. They were told that these problems need to be addressed by the individual Irrigation Companies themselves. This meeting only had to do with the Distribution of the water on the Cub River.
