WHEREAS, the rights to the use of the surface waters of Worm Creek and tributaries have been decreed by the Sixth Judicial District Court of the State of Idaho in the case of the State of Idaho vs. Margurett D. Ainscough, et al; and,

WHEREAS, the Department of Water Resources has the duty to supervise the distribution of the waters of the State of Idaho, pursuant to provisions of Section 42-602, Idaho Code; and,

WHEREAS, pursuant to Section 42-604, Idaho Code, the Director of the Department of Water Resources established Water District 13-A, Cub River Drainage; and,

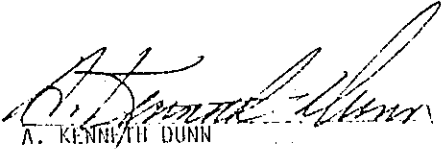
WHEREAS, the waterusers on Worm Creek and tributaries have requested the Department to include Worm Creek and tributaries in a water district; and,

WHEREAS, since some water from the Cub River Drainage is diverted into Worm Creek it appears that both streams should be within the same water district;

IT IS, THEREFORE, HEREBY ORDERED that Water District No. 13-A, Cub River Drainage, be amended to include Worm Creek and tributaries; and,

IT IS, FURTHER HERELY ORDERED that for distribution purposes the priorities of water use on Cub River and tributaries should be considered separate and apart from the priorities of water use on Worm Creek and tributaries.

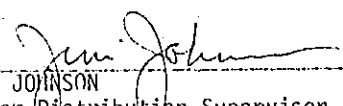
