I appreciate your help with our water problems.

I have been able to establish the Spring Creek Water out of Lamont Reservoir — Tom Peterburg owns the land that it angles through and onto Oneida Street. It flows west and into the northwest channel of Spring Creek. Lamont Reservoir was built in 1949. My sister married Seeburn Lamont's son who owned the farm that would have been inside the reservoir. There was water flowing through his farm. Tom said that was why he fived. Tom also knew about the water coming east into the

through his farm. Tom said that was why he lived. Tom also knew about the water coming east into the area south of Johnson Reservoir. This stream runs all year and would be another arm of Spring Creek. There are several springs coming up in the area south of Johnson Reservoir. This area I have indicated on the map some of the springs and where this water runs. The ditches and channels have been tromped badly and not maintained as the water flows through this area. There are probably 5 to 8 springs that come up throughout this area.

I was also told there are very good springs in the bottom of Johnson Reservoir. While they were repairing the dam and had all outside water turned out the reservoir rose 3 feet.

Tom also told me of a court decision regarding the Webster on Worm Creek and their water rights. The court was said to have ruled that since Preston Whitney dumped Cub River water into Worm Creek that the Cub River water was not distinguishable and so it became Worm Creek and he had full right to her decreed.
