Re: Regulation of Water Diversions in Water District 74

Dear Mr. Sager:

Your role as watermaster has increased importance this year because of the lower than normal stream flows in the Lemhi Basin. Snowpack measurements indicate that stream flows in the basin will be similar to those experienced in 1990, 1992, and 1994, the most recent dry years. The snowpack indicates that the runoff for this irrigation season will be about 50 to 60 percent of normal. Of course, stream flows and water demands will depend on the weather conditions that actually occur during the remainder of the spring and summer.

Particular attention is needed to ensure that waters of Idaho are used in accordance with valid water rights by regulating water diversions such that amounts diverted do not exceed the amounts authorized by valid water rights and that senior water rights are respected to prevent economic injury. Additionally, consideration of anadromous fish species in the Columbia River Basin makes it imperative that water diversions and uses be carefully managed and documented to demonstrate compliance with valid rights established under state law.

I ask that you take all appropriate actions throughout the irrigation season to ensure that rights are properly delivered and to keep an accurate record of all diversions within your district for which you are responsible. I have instructed staff in the Department of Water Resources Water Distribution Section to schedule a meeting with you as soon as possible to assist in evaluating the distribution and record keeping procedures and to evaluate the adequacy of measuring devices and control works in your district. If it is determined that improvements are needed, the Department will assist you and the water users to make the needed changes. Mr. Bob Foster of the Department's Salmon office will be in contact with you in the near future to schedule a meeting.

I recognize that your term of service does not usually commence until you are called upon by one or more water users and that the budget adopted at the annual meeting of your water district may be a constraint to providing the additional services that are needed this year.
