RESOLVED: The watermaster is to be paid four times a year-4/15/00, 6/15/00, 8/15/00. The last paycheck will be issued after the Watermaster's Report has been filed with the Water Resourse and all locks have been removed from the haedgates at the end of the irrigation season.
