

Re: Annual Water District Meeting for 2003

On February 3, 2003, I attended the annual meeting for Water District 67 (Weiser River). Vernon Lolley was reelected as the chairman, and Mary Ellen Pugh was reelected as secretary. **Bosco Bosler was also reelected as the watermaster**. All of the committees remained essentially the same. All of this should be carefully explained in Mary Ellen Pugh's minutes.

The costs of operating the district are exceeding the total assessment, and the waterusers raised the assessment from \$0.55 an acre to \$0.70 per acre.

The district meeting was as quiet as I've ever seen it.

ANNUAL MEETING OF WATER DISTRICT 67

FEBRUARY 3, 2003

The annual meeting of Water District 67 was called to order at 1:10 p.m. by Vernon Lolley at the Vendome Event Center on February 3, 2003.

Vernon Lolley called for nominations for Chairman. Harmon Horton nominated Vernon Lolley, seconded by Paul Striker. As there were no more nominations, Vernon was elected unanimously. John Sachtjen nominated Paul Striker as Vice Chairman, seconded by Carl McElhinney; and the motion carried unanimously. Harmon Horton nominated Mary Ellen Pugh as secretary, seconded by John Sachtjen, and again the motion carried unanimously.

Next the Credential Committee and Advisory Committee were reviewed. Paul Striker made a motion to accept both committees without changes for the coming year, seconded by John Sachtjen. The motion carried.

Next Paul Striker made a motion to elect deputies for the 2003 season. They are as follows:

At the present time Bosco did not have any nominations for the Rush Creek position. Therefore, Paul amended his motion to elect all deputies for the 2003 season with the exception of Rush Creek which would be approved by the Advisory Committee when needed. This motion was seconded by Harmon Horton and carried unanimously.

Harmon Horton nominated Bosco Bosler as Watermaster, seconded by John Sachtjen, and Bosco was elected without opposition. Bosco then presented the proposed budget for the coming season. In regards to the deputies' salaries, Bosco realigned the Rush Creek and Hornet Creek positions. Each cover approximately 20 head gates and each will be paid \$800 per month.

John Sachtien asked about the carry over amount in the budget. Gary Spackman from the Department of Water Resources stated that as long as that amount is in line with our foreseeable expenses, there is not a problem. Since we have been spending down our bank balance and to provide sufficient funds to meet the foreseeable cash flow, Harmon Horton made a motion to increase the assessment to 70 cents/inch for the coming year. This motion was seconded by Wendell Walker and carried unanimously. We might need to adjust the minimal rate next year.

Gary addressed the group and commended Bosco for a job well done. Gary stated that readiudication is on target for 2004/5 and some preliminary requests for drawings and maps have already been mailed out. Some adjustments will have to be made for water users who may have changed acreage covered in regards to amounts or priority dates. Department of Water Resources is attempting to describe all water use.

Due to budgeting cuts, personnel numbers at Water Resources is declining. Gene Gibson is currently on assignment with the Corps of Engineers, and if there is an overlap in responsibility, Water Resources will defer to other agencies

Vernon addressed a communication problem and asked all users to contact Bosco or Mary Ellen if there are changes or problems that the district needs to be aware of. As always, good communication is the key to solving problems. Bosco's cell phone number is 550-1225.

Harmon Horton made a motion to notify Washington and Adams Counties to collect the money for Water District 67 through the tax system and send it to the district. Carl McElhinney seconded this motion, and it carried unanimously.

Paul Striker made a motion to hold the next annual meeting for Water District 67 on Monday, February 2, 2004, at 1 p.m. Mary Ellen will again try to make arrangements to hold the meeting in Cambridge so that people from Council can attend more easily. She will notify Water Resources so that cards can be sent at the appropriate time. Harmon seconded the motion and the motion carried. John Sachtjen made a motion to adjourn the meeting, seconded by Harmon. The meeting adjourned at 2:40 p.m.
