## MEMORANDUM Hess Property Site Inspection (south of Lake Fork)

On 10/9/02 I made an on-site inspection of the Hess Property just south of Maki Rd on Hiway 55 near Lake Fork. The property is located on the east side of Hiway 55, 17 N-3E-Sec15-NWof NE, see attached map.

The pond is the result of a gravel extraction (pit) in progress. The outside dimensions of the pit are 300 ft (paced) per side square. The pit depth varies from approx. 1 ft to 10 ft with the northeast and southwest quarters being the lower. Groundwater had been intercepted in the deep areas of cobble rock (approx. 5 ft +), and was standing on the surface. A pump on the east side of the pit was removing seepage water. I did not observe the pumping rate. It appeared some other pipe works was in the process of being installed.

I am not sure if there are future plans for a development near the site. It appeared parcels to the south are being advertised for sale/development. Presently, the area is flood irrigated pasture with water from the Lake Fork Irrigation District/Lake Fork Creek.

I talked with Lance Hess the property owner. He has been unable the past several years to successfully get his irrigation water through several laterals due to property

subdividing and development. He is planning to share the Maki lateral with Maki's; the pond will be a rediversion/regulation for irrigation pumping. The water source is

Lake Fork Irrigation District. I checked with John Leedom the District Manager; Mr. Hess has water rights/shares. John does regulate his delivery off the main ditch, but does not regulate the Maki lateral. He was aware of the lateral delivery issues in that area, and the explanation sounded logical.
