1. The minutes of 1997 were read and approved.

- 3. Del moved and Ivan seconded to have next years meeting on the 1st Monday of March, which would be March 1, 1999 at 10 a.m. at the Donnelly Bible Church. Passed.
- 4. Paul moved and Del seconded to continue 65-D's membership.in the Idaho Water Users Association at \$50. Passed.
- 5. Paul moved and Ivan seconded to have John Shaw, Del Catlin and Mack Miller as the Advisory Board and George Duncan - Chairman, \$50; Linda Duncan - Sec.-Treas. \$150 plus \$50 for office supplies. Passed.
- 6. Ivan moved and Del seconded that the following resolution be continued. "Resolved, that no ditch, canal Co. or other water user shall have the right to demand and receive water and the Watermaster shall not deliver water to such user, until the amount due and payable from such user, as set by the budget, has been paid." Passed.
- 7. Paul moved and Del seconded to hire Ivan Phelps as Watermaster at \$30 per day. Passed.
- 8. Paul moved and Del seconded to change the way we assess for water used. Change from the 5 year average method to assessing for water used the previous year, plus \$5 record keeping fee. Passed.
- 9. Paul moved and Del seconded that we accept the amended budget for 1998 of \$2,960.65. Passed.
- The weirs are in good shape. Carey put in a new weir. Paul moved and Ivan seconded to continue the statement that "No water will be delivered to party or parties that the Watermaster deems responsible for the maintenance of a weir and or measuring device until the weir and or measuring device is repaired - replaced to the Watermaster's satisfaction." Passed.
- 11. New Business: Discussed setting regulations for new developments to leave easements, etc. for companies to be able to clean ditches, etc.
- 12. Del moved and Ivan seconded that the meeting be adjourned. Passed
