## RECOGNITION OF SUCCESSOR IN INTEREST TO CONTRACT FOR CASCADE RESERVOIR STORAGE

WHEREAS, the United States of America entered into a contract on August 29, 1973, Contract No. 14-06-100-7761, with Harvey N. and Selmah M. Gatfield for use of stored water accruing to 0.120 percent of the 525,000 acre-feet of "remaining capacity" of Cascade Reservoir, which percentage shall, so long as Cascade Reservoir has a total active capacity of 646,461 acre-feet, be treated as the equivalent of 627 acre-feet, on lands owned by the Contractor and described in the contract; and

WHEREAS, all rights, title, and interest in Contract No. 14-06-100-7761 were subsequently assigned to the MC Shelley Family Trust on October 30, 1994; and

WHEREAS, an authorized representative for the Shelley Acres Homeowners' Association states that the Shelley Acres Homeowners' Association is a legal entity representing the owners of the land to which water was to be provided under said contract and requests that it be recognized as the successor in interest to this contract (at mailing address c/o Tom Blandford, 9800 North, Highway 52, Horseshoe Bend, ID 83629);

NOW, THEREFORE, all right, title, and interest in Contract No. 14-06-100-7761, dated August 29, 1973, is hereby recognized to be held by the Shelley Acres Homeowners' Association. This contract action is effective only with the approval of the Contracting Officer as provided in Article 19 of said August 29, 1973, contract.
