




Dear Mr. Westra:

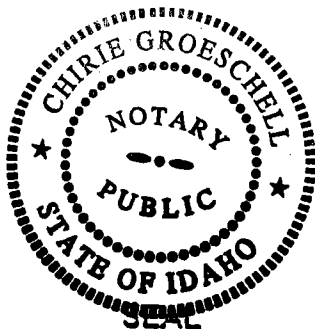



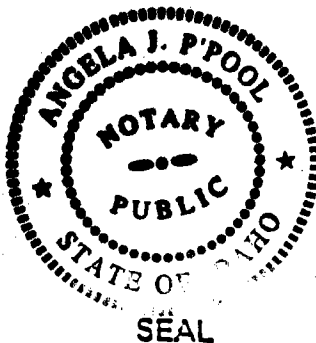
