Minutes of the annual Water Users Meeting of Water District 13-R held at 8:15 p.m. March 6, 2000, at the home of James D. Boyce, Oxford, Idaho.

Those in attendance were: James D Boyce, Benny Kendall, Burton Tew, James Roberts, Marion Olson, Chris Coburn and his boy Jason and Bret Yearsley.

Chris Coburn was elected chairman, to conduct the meeting. James D. Boyce elected secretary.

Minutes of the previous meeting were read and approved and a financial report given showing a balance on hand 1-1-2000 of \$997.65.

A motion was made seconded and carried by vote, that the Water Master salary remain the same at \$1500.00 annually and the Secretary at \$100.00. It was voted that the budget remain at \$2010.00 and if any unusual expenses arise, the water users will be assessed proportionately.

Resolutions adopted, pertaining to collection of the budget as per Idaho Code 46-618, which provides in part, authorization to the Water Master to withhold water deliveries or suspend water deliveries, in the event that delivery has commenced, from those users who have not paid their pro-rate share of the cost of operating the District as levied, until such time as their pro-rate share is paid. Also Section 442-619 Sub.11; the Water Master shall be authorized to act as Water District Treasurer and collect the unpaid water bill directly from the water user before delivering water. Due date of all 2000 assessments to be June 1, 2000.

In follow up of last years time limit of two years for the head gates that needed repair or replacement. It was reported that the one Benny Kendall and Clark Cox had replaced on the south ditch worked well, and Dee Boyce had completed his. Marion Olson reported that a head gate had been ordered and was being built for the north ditch down town diversion. Some discussion was held regarding some of the other head gates that need to be completed on the south and north ditch.

Marion Olson was nominated, seconded for Water Master, there being no other nominations, Marion Olson was elected by acclamation for Water Master for the year 2000.
