MINUTES OF THE ANNUAL MEETING OF THE "PORTNEUF-RIVER WATER-USERS, DISTRICT #29" HELD IN THE CITY BUILDING AT LAVA HOT SPRINGS ON MARCH 3, 1997 AT 12:00 NOON

97003557 (BOARD MEETING) PRESENT: K,V, HANSEN, HOWARD HALL, GRANT EGLEY, JIM ANDRUS, ROGER JOHNSON, ARLIN OLSON, & DALE HATCH

CHAIRMAN K.V. HANSEN conducted the meeting- - The minutes of the 1996 meeting were read and approved

MR. HANSEN asked Arlin if he was having any trouble with any of the measuring devices? Arlin said there was no trouble as far as he knew.

MR. HANSEN said that FRANK ARCHER hasn't used any water, but that was his own problem getting the water.

Mr. HANSEN asked Arlin about the KING CREEK PIPE? Arlin said there was no problem, some water goes by the pipe. MR. HANSEN said that pipe raises heck with him.

REVIEWED APPLICATIONS FOR WATERMASTER: There were two bids received. One from Arlin Olson for \$11,900. Another one from Hailey Hall from McCammon for \$12,000, or work as an Apprentice for \$1,000 a Year. There was also a letter from David Crea that was read. He said he would be willing to work as an understudy, but no fees were discussed. Arlin Olson thought that \$1,000 was too high to pay for an Apprentice. Roger Johnson mentioned another fellow from McCammon, TEX LUTHIE, who may be interested.

ROGER JOHNSON made a motion that we accept Arlin'S bid. SECONDED by THAYNE THOMPSON, all approved. HOWARD HALL said that Hailey Hall was nineteen years, and was a very good worker.

THAYNE THOMPSON said we need a back-up. Arlin Mentioned GEORGE EGLEY. The board agreed to let Arlin choose, WHO, and how many times to take the person, up to a Maximum of \$1,00

There were four deliquent assessments. Toponce Canat, John Marley, Roger Johnson, for Timothy O'SHAUGHNESSY a total of \$157.96. Roger Johnson agreed to get his and Timothy O'Shaughnessy's in. ALL Agreed no pay -- no water.

Took up Arlin's budget: \$12,780. Thayne T. made a Motion that we round figures to even dollars. All Approved. Howard Hall made a motion that we set the budget at \$14,000 Seconded bt Jim Andrus, voting Unanimous.

Discussed about putting the money that is in the Bank into a different fund. K.V. Hansen will talk to the BANK about this.

Howard Hall made a motion that we raise the Secretary's wages to \$500.00 Seconded bt Jim Andrus, voting Unanimous K.V. HANSEN nominated everyone to serve another year for the same pay. Also to retain the \$20.00 Minimum. All agreed

Howard Hall invited everyone to come to the next meeting of the FRIENDS of the PORTNEUF, on March 18,1997 at 7:00 P.M. in the Community BLDG. in Lava Hot Springs.

MR. HANSEN went over the expenses for the past year. (\$12,780.84) Deliquent \$157.96

He Proposed a budget of \$14,000 for the coming year, and proposed that the Secretary's wages be raised from \$300.00 to \$500.00 for the coming year.

GENE FAGNANT made a motion that we accept the \$20.00 minimum. seconded by Dean Day. Voting unanimous

ROGER JOHNSON made a motion that we accept the same board for next year except, Dale Hatch will replace him. Seconded by Kenneth Andrus. Voting unanimous

It was agreed to let Arlin choose his Assistant, no more comments about this.

David Crea said that according to the reports the Portneuf should be at about 145% of average. Steve Hebdon asked where and when were the Surveys taken? David said the SCS made a survey, they made a map. Feb. 1, 1997.

1992 was a record low year. 1984 was a record high. Dean Day said the flood years were dry years, but the ground was frozen.

When the reservoir is at 38 ft. it is about half full.
