

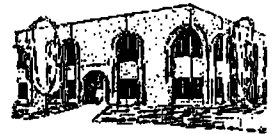


Dear Mr. Spackman:

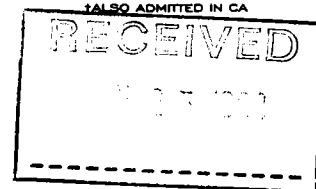
