NOTICE OF PUBLIC HEARINGS

The Director of the Idaho Department of Water Resources ("Director") is authorized to divide the state into water districts for the purpose of distributing water among appropriators under the laws of the State of Idaho. Section 42-604, Idaho Code provides authority for the Director to create, revise the boundaries of, or abolish a water district or combine two (2) or more water districts.

NOTICE IS HEREBY GIVEN, pursuant to Section 42-604, Idaho Code, that the Idaho Department of Water Resources (IDWR) will conduct two public hearings, as follows:

OF WATER DISTRICT NOS. 29-C, 29-F AND 29-U WITH THE NEW PROPOSED

The proposed expansion of Water District No. 29 and the proposed creation of a new water district described below both identify an overlapping or duplicate reach of the Portneuf River between its confluence with Harkness Creek and its confluence with Marsh Creek, including tributaries in the reach. The duplicate streams also include Indian Creek, which sinks near Inkom, Idaho prior to reaching the Portneuf River. The two proposals will not both be physically implemented at the same time, but a timed combination of the one proposal and then another proposal is possible.

Information Regarding Proposed Expansion of Water District No. 29:

A hearing for the proposed expansion of Water District No. 29 was held on March 2, 2009 in Lava Hot Springs but notice of that hearing was sent only to holders of water rights in the affected expansion area, and not to right holders within Water District No. 29 as required by Idaho law. A second hearing on this matter is needed to provide all water users in Water District No. 29 an opportunity to comment on the proposed action.

IDWR proposes the expansion of Water District No. 29 to include the Portneuf River and tributary sources between the confluence of Harkness Creek and the Portneuf River near McCammon, Idaho, downstream to the confluence of the Portneuf River and Marsh Creek near Inkom, Idaho. IDWR further proposes to expand Water District No. 29 to include Indian Creek, which sinks near Inkom, Idaho prior to reaching the Portneuf River.

The expansion of Water District No. 29 was proposed in response to requests by water users owning water rights diverted from several streams tributary to the Portneuf River in the vicinity between McCammon and Inkom, Idaho. Administration of water rights in Water District No. 29 has historically been limited to the Portneuf River and tributaries upstream of McCammon, Idaho, including Harkness Creek. Extending Water District No. 29 to include these additional water sources is required in order to properly administer the water uses and water rights from these sources.

At the March 2nd hearing, a representative of the Water District No. 29 Advisory Committee testified in opposition to the proposed expansion of Water District No. 29. A number of water right holders in the proposed expansion area testified in support of the expansion. No right holders in the proposed expansion area testified against inclusion of the area in a water district.

Information Regarding Proposed Creation of a New Water District for the Lower Portneuf River and tributaries, and the Proposed Combination of Water District Nos. 29-C, 29-F and 29-U with the New Proposed District:

IDWR proposes creation of a new water district to include the Portneuf River and tributary sources between the confluence of Harkness Creek and the Portneuf River near McCammon, Idaho, downstream to the Shoshone-Bannock Tribal Reservation boundary near Chubbuck, Idaho, excluding Marsh Creek and tributaries, and Pocatello Creek and tributaries. IDWR further proposes to combine Water District No. 29-C, Mink Creek and tributaries, Water District No. 29-F, Rapid Creek and tributaries, and Water District No. 29-U, Jackson Creek and tributaries, with the new proposed water district for the Lower Portneuf River. The areas to be included in the district are shown on the map in Attachment A of this notice. All of the water sources and water rights affected by these proposed actions are located within Bannock County. Water District Nos. 29-C, 29-F and 29-U are currently inactive water districts, meaning that no watermasters have been elected and no water district budgets adopted to provide for the delivery of water rights from those water sources. IDWR also proposes to include Indian Creek in the new district. Indian Creek is located west of the Portneuf River near Inkom, Idaho and sinks prior to reaching the Portneuf River. Creating a new water district for the Lower Portneuf River area and tributaries, including Indian Creek, and combining Water District Nos. 29-C, 29-F and 29-U with the new proposed district is required in order to properly administer the water uses and water rights from these sources.

Information and testimony presented at both hearings on May 12, 2009 will create a record upon which the Director will rely to determine whether the proposed actions for expansion, creation and combination of water districts are appropriate. It is important that holders of water rights understand the proposed actions and participate in the hearings. IDWR Water Management Division

Administrator, Gary Spackman, will serve as the hearing officer for both hearings. Persons attending the hearings will be provided an opportunity to make an oral presentation regarding the proposed actions. Written comments may be submitted to the hearing officer at the hearings or at any time prior to the close of the written comment period on May 22, 2009. Written comments not presented at the hearings should be sent to the Director, Department of Water Resources, PO Box 83720, Boise, Idaho, 83720-0098.

The hearings will be conducted in accordance with IDWR's Rules of Procedures (IDAPA 37.01.01). These rules may be viewed from the State of Idaho Department of Administration's website as follows: www.adm.idaho.gov/adminrules/rules/idapa37/0101.pdf

The hearings will be conducted in a facility that meets the accessibility requirements of the Americans with Disabilities Act. Should you require special accommodations in order to attend, participate in, or understand the hearing, please contact the Department of Water Resources at least five days prior to the hearing.

This notice of hearings has been sent to all surface water right holders of record in Water District No. 29 that are currently assessed by the district and notified of the annual district meeting, and holders of surface water rights with sources from the Portneuf River and tributaries between the confluence of Harkness Creek and the Portneuf River near McCammon, Idaho, downstream to the Shoshone-Bannock Tribal Reservation boundary near Chubbuck, Idaho, excluding Marsh Creek and tributaries, and Pocatello Creek and tributaries. Notice has also been sent to right holders with sources from Indian Creek, Mink Creek and tributaries, Rapid Creek and tributaries, and Jackson Creek and tributaries.

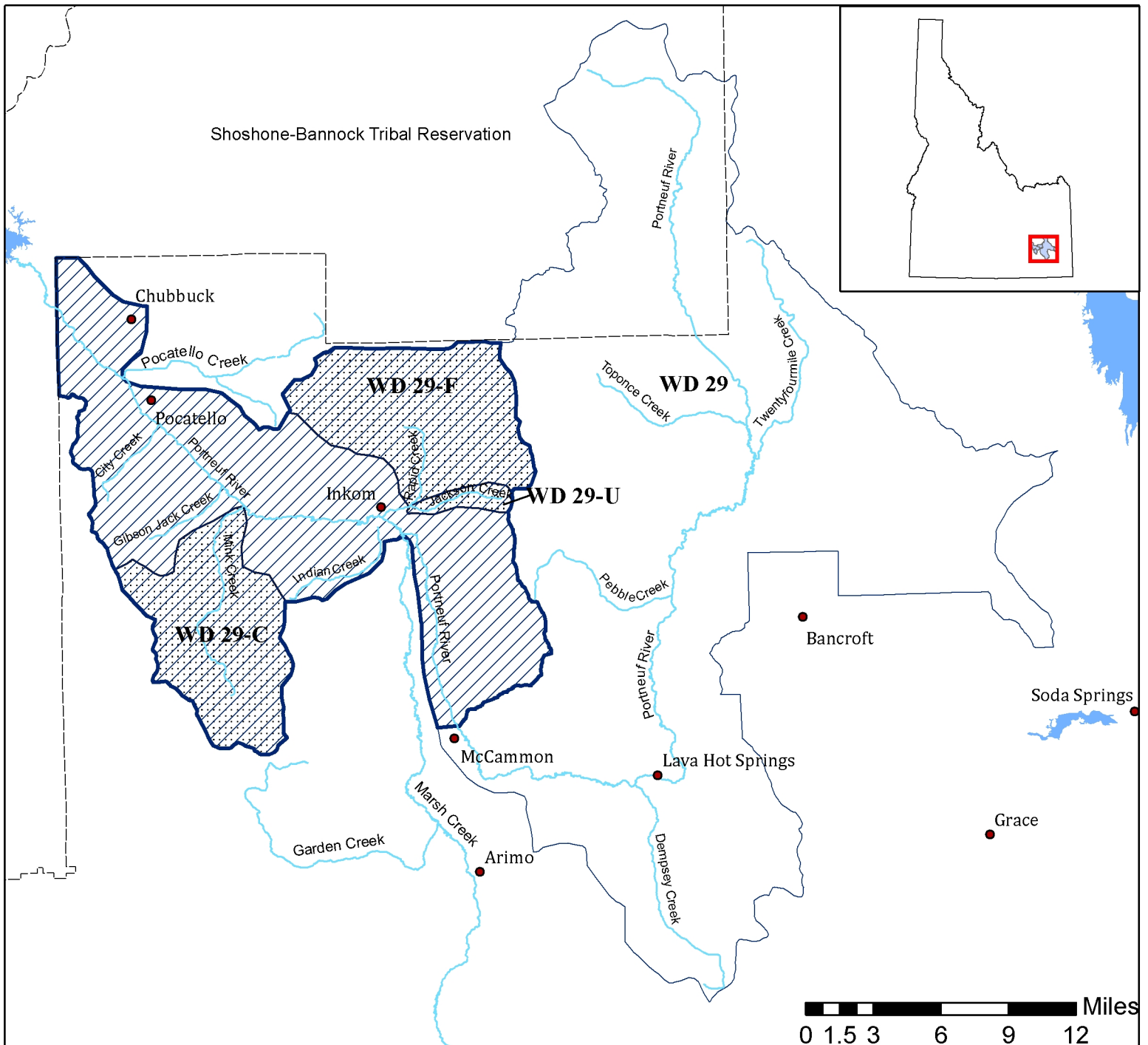

Proposed Water District Creation

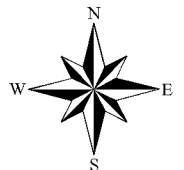
Lower Portneuf River and Tributaries
