Secretary read the 1995 minutes and gave County Treasurers balance of \$271.08. There were no bills in 1995, some will not have to have a budget for 1996.

Minutes were approved by Luther Cook and seconded by Mike Davison.

Luther Cook made motion and Mike Davison seconded ~~by Luther Cook~~ to have all officers same as 1995.

Watermaster: Randy Davison. Chairman: Elmer Ireland. Secretary: Barbara Ireland.

All Resolutions Same as Previous Years:

Resolved:

That no ditch, canal company or other waterusers shall have the right to demand or receive water and the Watermaster shall not deliver water ^{to} such persons until all dues fixed by budget the amount due and delinquent have been paid.

Resolved:

That when freezeing weather comes in the fall, the water shall be turned out of the ditch by some reliable persons in order to protect canal and the headgate.
