That no ditch, canal company or other waterusers shall have the right to demand or receive water and the Watermaster shall not deliver water to such persons until all dues fixed by the budget the amount due and delinquent have been paid.

### Resolved:

That when freezeing weather comes in the fall, the water shall be turned out of the ditch by some reliable persons in order to protect canal and headgates
