Thank you for your note of introduction and the information concerning correspondence and reporting. I perform two duties for the district, that of watermasster and of treasurer.

As treasurer, it is now my turn to apologize. I didn't realize until today that a financial statement needed to be submitted annually to IDWR. Enclosed are financial statements for years March 1, 2002 through Feb 28, 2003 and March 1, 2003 through Feb. 28, 2004.

When the Owyhee County Treasurers Office quit acting as the collection and disbursement agency for District 57-R they elected/hired a treasurer. It wasn't until they had a budget shortfall (by paying the treasurer) that they realized they would have to come up with some way to recover the "administrative" costs of acting as their own collection agency.

Last year was my first year to perform the duties of treasurer. The prior treasurer had failed to deposit checks, hadn't kept up with the required Form 941 tax reports and didn't understand what to consider as "administrative costs" (such as employer matching FICA and Medicare contributions) that needed to be billed. It is my belief that is the reason the cash on hand and accounts receivable do not total the budgeted amount of \$5,000. I will bring this to the attention of the District Chairman and Secretary. I feel that unless we can discover what and where the unbilled amounts or discrepancies came from, and bill them out, it will be difficult to bring the budget back into balance.
