Meeting was called to order at 1:15 PM.

In the absence of Blaine Hulet as chairman, Paul Nettleton presided as Secretary.

Present: Craig Baker, Irene Tyson, Paul Nettleton, Jay Hulet, Don Hartley with Dave Tutthill and Cindy Hedges present from Water Resources.

Minutes were approved as read.

Officers were elected (same as last year).

Blaine Hulet, chairman

Paul Nettleton, secretary

Mary Blackstock was reelected watermaster at same salary.

Discussion: Dave Tutthill reported concerning Murphy Mutual Canal lateral users association. Meeting will follow. \$

Dave reported statewide snow basin drainage at 50% of normal. Paul reported 1½ feet of snow in Silver City estimating that this is also approx. 50% of normal. Recent heavy snows in the watershed may have increased this somewhat. Jay reported his reservoir at approx 17 feet. Craig reported Nakas Lake at basically full with 1 foot of top freeboard. Cindy reported on a watermaster violation on the Hulet Reservoir headgate. No action will be taken as no damage was done and it was mostly a misunderstanding. Cindy wanted water users to be aware of the incident and passed out a letter concerning it. There was also brief discussion concerning a benefited use involving flood irrigation from the canal on Joyce Livestock Co. land.

Meeting adjourned at 2:30 PM.
