Murphy Mutual Canal Co. is a registered non-profit Corporation of Idaho. Corporate Stock Holders are Jay Hulet 470 shares, Paul Nettleton 270 shares, and the following Hulet interests own 20 shares each namely-Blaine Hulet, Don and Barbara Hartley, Marilyn Allen, Janice Rudeen, Linda Ihli and Marcia Hulet. Making a total of 860 shares.

Murphy Mutual Canal Co. is set up to deliver water from Sinker Creek to Lands on Murphy Flat. In 1967 Jay Hulet bought the Murphy Flat area from Nettleton, Mitchell and Ihli in its entirety including 68% interest in Murphy Mutual Canal Co. Nettletons retained 32% of Murphy Mutual Canal Co. stock.

Nettletons rights to water deliveries into the canal are limited to a maximum of 798.5 minor inches (14.77 cfs.) at the Canal head for canal deliveries.

As of this date, May 15-95, all water deliveries to Murphy Mutual Canal Co. will be ordered by Jay Hulet, who is work director, and water master for Murphy Mutual Canal Co. This order for water deliveries applies to the following stock holders. Jay Hulet, Paul Nettleton, Blaine Hulet and Don Hartley who are users of this diverted water. Stockholders who are not farming are Marcia Hulet, Linda Ihli, Janice Rudeen and Marilyn Allen. Jay Hulet has the authority to vote their stock.

The following farmers rent ground from the Stockholders, and receive water through the Murphy Mutual Canal Co. Karl Steiner, Vorn Steiner, James Doughty, Dwayne Lemon, and Terry Hipwell.

As long as the Hulet interests are receiving water the Nettleton interest must abide by, and order water through the Murphy Mutual Canal Co. Manager (Jay Hulet) who in turn will order from the Sinker Creek Water Master.
