RESOLUTIONS PURTAINING TO THE TIME AND MANNER OF COLLECTING THE BUDGET AS ADOPTED AT THE ANNUAL MEETING OF THE USERS OF

WATER DISTRICT No. 57-D

Meeting called to order by Chairman Graig Baker at 1:15 PM at the Murphy Courthouse. In attendance were Graig Baker, John Edwards, Mike of Kli, Don Hartley, Paul Nettleton and Girdy Hodges and Maria Minicusci from 10 UR.

Minutes were read and approved.

Officers were elected: Craig Daker, Chairman; Paul Nettleton, Sec.

Waternaster Compensation was fixed at 50 per trip and 30 & milage. Cindy read a letter of resignation from Mary Blackstock. Paul was appointed as a committee of one to find watermaster candidates and to report to the other members by telephone.

Budget was approved (same as last year).

Resolutions passed

1. that all water users pay water dist, fees by april I of the current water season.

I that to no water be delivered to any water user not paid up !
