

 - D. Our minimum rate now stands at \$20.00, according to the Water Resources, this rate cannot not be raised beyond this amount. The question concerning minimum rate is: Should regular users that show a billing amount of less than \$20.00, be billed the minimum.
 - E. Measuring devices as well as headgates need to be properly installed before water can be delivered.
 - F. Recommendations from the 1996 or the newly appointed 1997 Advisory Board.
