



Dear Mr. Eckert;

We acknowledge receipt of the minutes of your 1995 water meeting, your 1995 adopted budget, your 1994 watermaster's report, your 1994 internal audit, and the oaths of office for this year's watermaster and treasurer. We have not received your proposed budgets for 1994 and 1995 as required by Sec. 42-615 of the Idaho Code. You can certainly submit audits if you so desire, but none is required unless your district budget exceeds \$50,000. The law was changed a couple of years ago to eliminate the needs for audits in most water districts.

With regard to your adopted budget, it is not in compliance with Sec. 42-612 of the Idaho Code. All monies collected must be for approved expenses of the district, such as watermaster salaries, payment of ongoing debts, repair of ditches, etc. Your budget shows that funds will be collected for which no purpose has been approved. You can build up your bank account in anticipation of an upcoming expense, but no mention is made of this in the budget. We will accept the budget as submitted for this year, but future budgets must be in compliance with Idaho law.

I also noticed that you set a late charge of 18% for overdue assessments. Sec. 42-613 of the Idaho Code sets this rate at 8%.

Your certificate of appointment as treasurer for 1995 is enclosed.

For your information, Gary Funderburg is no longer involved with water districts. He no works exclusively in the well drilling and injection well programs. I took over the water district program last year. Please contact me in the future if you have questions or require assistance.
