The meeting was called to order by the chairman Basil Fairchild, at 7:20 p.m., on January 22, 1998. The meeting was being held at the Oakley High School, Oakley, Idaho. Members in attendance were: Rickie Spearin, Sam Spearin, Trent Anderson, Wade Zollinger, Linda Zollinger, Bill Wells, Lisa Beams, Steve Manning, Basil Fairchild, and Kevin Smith, Donald Bedke, and Kay Wells.

Basil Fairchild was nominated for chairman by Kevin Smith. Steven Manning seconded. Richie Spearin moved nominations cease. Approved by all members in attendance.

Linda Zollinger was nominated for secretary / treasurer by Kevin Smith. William Wells seconded. No further nominations. Approved by all members in attendance.

Report by Wade Zollinger, representing Spring Creek, weirs cleaned up by Trent Anderson. First one leaks and needs a new metal piece. Private weir needs to be repaired by Marchant and Beams.

Other repairs which need to be done is the culvert / crossing needs fixed on Mill Creek. Clean out by Rose Fairchilds house. Mill Creek -need to repair cement by new water pond in Zollinger field. Don Bedke needs to talk to Jeff wadsworth about the water jog out. Needs to fix this area, may cause flooding. Rose bushes need to be cleaned out by Marchant's and Zollinger's field.

Motion made by Donald Bedke to use money in fund to fix up and repair streams. Wade Zollinger seconded with comment to do all we can before laws change and we can not improve. Need to make needed repairs.

Motion made by Wade Zollinger to transfer funds from Key Bank to D L Evans Bank. And to have Kevin Smith check on CD's. Seconded by Donald Bedke. All in favor. Motion passed.

Motion made by Steven Manning to put in a Gravel Pack and large pipe at Bruce Mitchell's place to repair the problem with watercress buildup and plugging the stream. It would take large gravel then a pipe with holes and then it would be set on a gravel bed. Mr. Mulestine put in one for Kevin Smith and it worlds really well.

There being no other business, Wade Zollinger made the motion to adjoin the meeting. Seconded by Steve Manning. The motion passed. Meeting adjourned.
