We have received the minutes of this year's water meeting, which state that you have been elected as watermaster of your district. You are not a legal watermaster unless appointed by this Department, however, so an oath of office is enclosed for your use. Once I receive your notarized oath, a certificate of appointment will be issued. As watermaster, you are also required by law to complete a report of deliveries at the end of the irrigation season; two copies of the report form are enclosed for your use. You will also receive proposed-budget forms prior to next year's water meeting, which you will need to complete and take to the meeting. A copy of the proposed budget also needs to be sent to this office upon completion. Since your district has apparently decided to become active again, these documents must be submitted annually by whoever is watermaster or expects to be watermaster for the following year. ## RESOLUTION PERTAINING TO THE TIME AND MANNER OF COLLECTING THE BUDGET AS ADOPTED AT THE ANNUAL MEETING OF THE WATER USERS OF WATER DISTRICT NO. 45A

Water District 45A Oakley, Idaho February 20, 2001

The meeting was called to order by Basil Fairchild, at 7:30 p.m., on February 20, 2001. The meeting was being held at the Oakley High School, Oakley Idaho. Members in attendance were: Jarred Bedke, Chris Poulton, Kay Wells, Jerry Zollinger, Basil Fairchild, Gerald Marchant, Eugene Matthews, Linda Zollinger, Kevin Smith, and Robert Manning.

First order of the meeting was to elect chairman. Kay Wells nominated Basil Fairchild, Eugene Matthews seconded and Chris Poulton moved that nominations cease. All were in favor and Basil Fairchild is to chairman for the year (April 1, 2001 to March 31, 2002).

Minutes for the 2000 meeting were handed out and reviewed. Kay Wells made to motion to accept the minutes. Seconded and approved.

Basil Fairchild assigned committeemen:

Kay Wells for Summit Creek. Jerry Marchant for Mill Creek Wade Zollinger for Spring Creek.

Motion was made by Kay Wells to change assessment rate to \$2.50 per Minor Inch. Seconded by Gerald Marchant and all approved.

Basil discussed that all water bills must be paid, and all headgates, ditches, weirs need to be cleaned and repaired at each members location before their water is turned on.

Basil made motion to transfer part of the funds into a CD and gain more interest. We have extra funds drawing interest at D. L. Evans Bank at the present. Seconded by Kay Wells and all approved.

Basil asked on what work needed to be done on the streams. Basil set a Inspection Day and asked that the committeemen; Kay Wells, Jerry Marchant, and Wade Zollinger, plus Basil Fairchild and water master are to meet on March 24<sup>th</sup> at 10:00 a.m., to check out and see if there are any problems which need taken care of.

Watercress is building up near Bruce Mitchell's home. Kevin Smith said Derrick Smith would clean this for \$100.

Kay Wells nominated Lisa Beams as Water Master. Seconded by Kevin Smith.

Salary for the water Master will be set at \$3,000 per year (April 1, 2001 to March 31, 2002)

Turn off all stock water diversions on April 1<sup>st</sup>.

Put on turns from the very first of the water year. Unless there is not enough water for delivery.

Bruce Bedke check on 12 ½ hours on Summitt creek not on payment sheet.
