Basil Fairchild called the meeting to order at 7:30 p.m., on February 12, 2008. The meeting was held at the Craig Hawker's home, in the Oakley Basin. Bruce Bedke nominated Linda Zollinger as Secretary. Seconded by Eugene Matthews. Motion was approved.

Jared Bedke made motion to leave the assessment rate at \$3.00 per Minor Inch made motion. Seconded by Gerald Marchant. Motion made to make up difference use out of existing bank balance.

Motion was made by Gerald Marchant to set the Water Master salary at \$4,000.00 for the water Year (April 1, 2007 to March 31, 2009). K Wells said he would be willing to be the Water Mater for \$4,000. Motion passed.

Gerald Marchant nominated Kay Wells as Water Master. Jared Bedke seconded. Motion was approved.

Old business:

Basil asked for a motion that all water bills must be paid, and all head gates, ditches, weirs need to be cleaned and repaired at each member's location before their water is turned on. The diversion is the landowner's responsibility and the weirs are the water districts responsibility. Craig Hawker made the motion and Jared Bedke seconded.

Basil Fairchild assigned committeemen the same as last year:

Basil Fairchild made the motion to set District 45-A water to Start April 1, 2008 and end October 1, 2008. But make note by water master that the rest of the year the water is being used for livestock. Seconded by Bill Wells.

Jared Bedke discussion on the possibility of lots to be sold by Kevin Smith. He discussed the concerns of the members on the responsibilities of water users. The discussion was the difference between ditches and creeks. Also, people buying lots and high water flooding. The problem would be people not using good judgment when building new homes. Also, discussed whose responsibility it is to protect children from playing in the creeks, and possible injury. Do the homeowners need to build fences?
