THROUGH MY YARD. I WAS HOME THAT AFTERNOON AND THERE WAS
NEVER ANY WATER IN MY YARD.

NEXT THEY SHOW MAY 28, 2001. THEY SHOW A BIGGER STREAM
IN THE SAME DITCH. THEY ALSO SHOW THE CREEK THAT DAY. I
MEASURED THE IDAHO WEIR MAY 28. THERE WAS 11 CFS SO YOU CAN
SEE HOW MUCH WAS BEING DIVERTED IN UTAH. ON MAY 28 THERE
WAS SOME WATER WHICH MADE IT DOWN TO MY YARD. AT
ABOUT 7:00 PM I WENT UP TO SEE WHAT WAS GOING ON
WITH THE WATER AND IT HAD BEEN SHUT OFF. WHILE I WAS

UP LOOKING AT THE DITCH A SHERIFF'S DEPUTY CAME
TO ARREST ME SO I TOOK HIM DOWN AND HE TOOK SOME
PICTURES OF THE WATER RUNNING ACROSS THE ROAD AT THE
STATE LINE. I ~~TOOK~~ SENT HIM A COPY OF THE COMPLAINT
THAT I SENT YOU. HE DIDN'T ARREST ME.
