  SECRETARY/TREASURER MAXEEN WARD READ THE MINUTES FROM THE
  1994 MEETING AND THEY WERE APPROVED AS READ.
  REPORT OF MONEY WAS AS FOLLOWS:

- 8. FIX COMPENSATION FOR WATERMASTER:
  PAUL WARD MADE A MOTION THAT THE WATERMASTER'S COMPENSATION
  SHOULD REMAIN AT \$50.00 PER DAY. THE MOTION WAS SECONDED
  BY GLEN PARKE AND THE VOTING WAS UNANIMOUS.
- 9. ELECTION OF WATERMASTER:
  GLEN PARKE NOMINATED TOM HUTCHISON AND HARRY DSCHAAK
  2ND THE NOMINATION. THERE WERE NO OTHER NOMINATIONS AND
  TOM HUTCHISON WAS CHOSEN BY ACCLIMATION.
- 10. NEW BUSINESS: TOM HUTCHISON SAID THAT THE CREEKS COMING OUT OF BOTH CANYONS ARE IN BAD SHAPE AND NEED SOME WORK BUT THAT THE WATER RESOURCES COULD NOT GIVE US A PERMIT TO DO THE WORK. IT WAS SUGGESTED THAT THE ADVISORY BOARD SHOULD LOOK INTO THE SITUATION TO MAKE SOME RECOMMENDATIONS. STAN LLOYD SAID THAT A PACKET OF INFORMATION IS COMING WITH AERIAL PHOTOGRAPHS AND STEVE FRIEBURGER IS WORKING ON A TOPOGRAPHIC MAP OF THE WATER DISTRICT. IT WAS ALSO DISCUSSED THAT WE LOOK INTO EITHER INCORPORATING OR FORMING AN IRRIGATION DISTRICT WITH A DIRECTOR AND BOARD TO ADDRESS ALL ISSUES PERTAINING TO POLICY.IT WAS MENTIONED THAT IF WE DON'T HAVE A PLAN IN THE FUTURE, SOME ONE ELSE MAY BE ABLE TO COME IN AND SET POLICY FOR US. TOM OTTLEY MADE AMOTION THAT THE CHAIRMAN AND ADVISORY BOARD COLLECT INFORMATION AND CALL A MEETING TO DISCUSS THEIR FINDINGS WITH THE WATER USERS. ALVIN NEDDO SECONDED THE MOTION AND VOTING WAS UNANIMOUS. KELLY CHRISTENSEN FOR THE IDAHO WATER RESOURCES TO US BRIEFLY ABOUT TWO IMPORTANT ISSUES THAT ARE NOW BEING DECIDED IN THE COURTS PERTAINING TO THE RELATIONSHIP BETWEEN SURFACE AND GROUND WATER, AND THE ISSUE OF FORFEITURE OF WATER. IT WAS MENTIONED THERE IS MONEY AVAILABLE FOR PROJECTS FROM THE WATER RESOURCES BOARD IF A PLAN CAN BE PRESENTED.

  15 DAYS FROM RECEIPT OF WATER BILLS, AND SAID AMOUNT, IF
