"That no ditch or Canal Company or other water user shall have the right to demand and receive water, and the water master shall not deliver to such person until the amount due and payable from such as fixed by the Budget has been paid, said amounts, if not paid, shall bear interest at the rate of 8% per annum. Also, the water user must present to the Water master his paid receipt or other proof that his budget has been paid before he can demand water."
