MINUTES OF WATER DISTRICT 43-C HELD JANUARY 29,2005 RAFT RIVER ELECTRIC BOARD ROOM MALTA, IDAHO

THE MEETING WAS CALLED TO ORDER BY CHAIRMAN PAUL WARD AT 12 NOON.
THE FIRST ORDER OF BUSINESS WAS TO SELECT A CHAIRMAN. BILL WICKEL NOMINATED PAUL WARD AND TOM WARD SECONDED THE NOMINATION. THERE WERE NO OTHER NOMINATIONS. BILL WICKEL NOMINATED MAXEEN WARD TO CONTINUE SERVING AS SECRETARY AND THAT NOMINATION WAS SECONDED BY LARRY KINCADE. THERE WERE NO OTHER NOMINATIONS. THE CREDENTIALS COMMITTEE REMAINED THE SAME AS THE PREVIOUS YEAR.

NEXT ON THE AGENDA WAS SELECTION OF THE WATER MASTER. LARRY KINCADE NOMINATED ROGER MUSSER AND BILL WICKEL SECONDED THE NOMINATION. THERE WERE NO OTHER NOMINATIONS AND THE VOTING WAS UNANIMOUS.

ROGER ASKED FOR A RAISE IN COMPENSATION. HE SAID HE WOULD LIKE \$60.00 PER DAY. THIS WAS VOTED ON AND UNANIMOUSLY AGREED UPON. THERE WAS A DISCUSSION ON PROPER MEASURING DEVICES ON THE DITCHES AND WHAT SOME OF THE WATER MASTERS RESPONSIBILITIES OF THE WATER MASTER ARE.

DON JOHNSON WOULD LIKE TO HAVE SOME ONE FROM WATER RESOURCES ATTEND OUR YEARLY MEETING. HE SAID HE HAD CALLED AND THEY INDICATED THAT THEY ONLY WORK 5 DAYS A WEEK AND AS LONG AS WE HAVE OUR MEETING ON SATURDAY THEY CANNOT DO THAT. IT WAS DISCUSSED AND DECIDED THAT THE SECRETARY WILL CHECK WITH RAFT RIVER ELECTRIC AND SEE IF THE BOARD ROOM COULD BE USED ON A FRIDAY AND IF SO TO EXTEND AN INVITATION TO WATER RESOURCES TO SEND A REPRESENTATIVE.

ADVISORY COMMITTEE FROM LAST YEAR WAS TOM OTTLEY, STAN LLOYD AND TED HIGLEY. MERLIN OTTLEY MADE A MOTION THAT THEY REMAIN FOR THE COMING YEAR AND BILL WICKEL SECONDED THE MOTION. VOTING WAS UNANIMOUS.
