Re: Transfer No.s 5137, 5138 and 5139; Ownership Information for Larry Schoen, Water Right NO. 37-00351B

Dear Norma.

I have reviewed transfers 5137, 5138 and 5139 with respect to your questions concerning the source of water for the water rights under these transfers. Transfers 5138 and 5139 allowed diversion of certain surface water rights from ground water wells. The official source of water under the rights associated with these transfers therefore is ground water. Note the conditions on these transfers that limit the diversion of ground water to times when water is available under the priority rights from the Big Wood River. Transfer 5137 did not involve approval to divert ground water under those rights associated with the transfer.

I have enclosed a copy of a letter from the Nature Conservancy to Larry Schoen concerning the sale of water rights 37-00351B and 37-00352B. A copy of this letter is included in our files. Pam Skaggs has advised me that the Department accepted this letter as sufficient documentation of ownership of the rights for purposes of processing Transfer No. 5312. The Department's official records reflect that Schoen is the current owner of these two rights.

I have not yet had a chance to discuss your letter of August 10 with Norm Young concerning the various rights that are diverted from ground water wells. We do plan to contact you soon regarding this matter. Please contact me if you have further questions regarding the referenced transfers and water rights.

Dear Larry,

Based on my conversations with you, the Conservancy intends to sell and convey to you Water Right No. 37-00351B and Water Right No. 37-00352B. This sale is contingent on approval of the transfer of these water rights to land owned by you, and will be null and void if the transfer is denied by the Idaho Department of Water Resources.

Please understand that this is merely a letter of intent which is not binding, may not be relied upon as the basis for a contract by estoppel, and that neither you nor the Conservancy shall be bound until an agreement for the purchase and sale of water rights has been duly executed and delivered.
