HIGH WATER AT MUD LAKE

Department of Water Resources
Eastern Region

Moved: Gerald Messerli, seconded by: Keith Shuldberg, passed

Be it hereby resolved, that the watermaster be authorized to determine when diversion is needed and to divert any high water. That such water be considered stored in the aquifer, with rights to the water being retained by the District. Diversion of said waters would be by diverting at the Lone Tree diversion site, and pumping through the diversion canal at the Mud Lake Water Users.

COLLECTION OF WATER ASSESSMENTS

Moved: Gerald Messerli, seconded by: Keith Shuldberg, passed

Be it hereby resolved, that no ditch, canal company, or other water user shall have the right to demand and receive water, and the watermaster shall not deliver such water, until full payment is made. Said payment becomes due April 1, and becomes delinquent April 15, and if not paid by April 15, shall bear interest from the date of April 1, until paid at the rate of 8% per annum. Be it further resolved that government agencies be exempt from the above provisions to the extent necessary for them to comply with payments according to the provisions of Federal law, and that the Watermaster of District #31, be authorized to enter into contract with said agencies of the United States for payment of assessment as provided in the budget.

We order that the water district is out no costs from any source of the regular water district funds and that recording and reporting be separate from the regular water district water reports and budgets.
