VDOLLED VI THE ANNUAL MEETING OF THE WATER USERS OF RESOLUTIONS PERTAINING TO THE TIME AND MANUER OF COLLECTING THE BUDGET AS

WATER DISTRICT No. 32-D

A resolution for collection of water assessment was adopted as follows:

No ditch, canal, or other water user shall have the right to demand and receive water until full payment due is paid. Payment shall become delinquent May 1 and if not paid by May 1, the payment shall bear interest from April 1 at the rate of eight per cent (8%) per annum.

The watermaster shall not deliver any water until full payment/is made.
