MINUTES OF ANNUAL MEETING OF WATER USERS OF DIST. NO. 33, LITTLE LOST RIVER, MARCH 5, 2001

The meeting was held at the Little Lost River Community Center at Howe, Idaho on March 5,2001. Pres. and Chairman Jim Andreason presided. Secretary Leo Amy read the minutes pf the 2000 meeting. They were approved as read.

1. Selection of Chairman and Secretary: Dean Mays made a motion that the same Chairman and Secretary be retained . Motion seconded and carried. Chairman Jim Andreason and Secretart Leo Amy retained for the year 2001.

2. Appointment of Credentials Committee: It was decided that credentials were not necessary at this meeting.

3. Fixed compensation to be paid Watermaster: Don Isham moved to raise the Watermaster salary to \$72.00 per day. Motion was seconded and carried. It was \$70.00 last year.

4. Adoption of Budget: Dean Mays moved that the budget be set at 100% of the five year average. Motion was seconded and carried.

5. Adoption of Resolution pertaining to collection of budget: Don Isham moved to keep Resolution, Item No. 6(b) for collecting the budget. Motion seconded and carried. Resolution, Item 6(b) is as follows: That no ditch, canal company or other user shall have the right to demand and receive water and the Watermaster shall not deliver to such person until the amount due and payable from such user, as fixed by the budget has been paid.

6. Election of Watermaster: Jerry Pancheri moved to accept the application of David Andreason as Watermaster for the year 2001. Motion was seconded and carried.

7. Selection of Advisory Committee: Leo Amy moved to retain the same Advisory Committee. Motion seconded and carried. Jerry Pancheri, James Mays and the Chairman of the Blaine County Canal, will be retained.

8. Don Isham moved to keep Pat Woodie as Treasurer for the year 2001. Salary to remain at \$400.00. Motion seconded and carried.

James Mays made a motion to have David Andreason contact Vance Hawley about the pump radio. If there are problems that need to be discussed another water meeting will be scheduled. Motion seconded and carried.
