RE: DELIVERY CALL ON THE WATERS OF THE BIG LOST RIVER

Dear Watermaster:

In compliance with and pursuant to the SRBA ORDER OF PARTIAL DECREE FOR GENERAL PROVISIONS IN ADMINISTRATIVE BASIN 34 and IDAPA Rule No. 37.03.12.040 the undersigned water right holders, each holding valid SRBA Partial Decree(s), call for the delivery of their surface water right(s) in their respective priorities and quantities to their various point(s) of diversion at the commencement of the 2004 irrigation season. If it is thought or determined that these priority calls for natural flow water rights are not deliverable to their respective point(s) of diversion at the commencement of the irrigation season, we call for the impoundment of these same water right supplies into rotation credit as described in Rule 40.02.d.iii and g. for the purpose of "charging the system" downstream from the Mackay Reservoir.

Pursuant to Administrative Rule No. 40 and by virtue of this call, we expect all upstream junior diversions which are from an administratively connected source supply to our prior rights be curtailed until such time as our water rights are fully satisfied (with the exemption of the seepage flows through the embankment of the Mackay Reservoir described in General Provision No. 2). This call also applies to any prior rights which may exist where no actual delivery call has been made pursuant to this same rule.

Incorporated in this same call we request the commencement of the irrigation season for Basin 34 not be initiated prior to the May 1st date as described in Rule 40.04 unless expected water supply forecasts or actual conditions were to change substantially.

Water rights on diversions from the Big Lost River below Mackay Reservoir

The following list includes diversions below Mackay Reservoir that are currently part of the Big Lost River Water Right Accounting (BLWRA) program. This list does not include water rights for instream stockwater or non-consumptive recreational ponds.

This list was prepared based on IDWR records and diversion inventory data available as of February 2004. This list is not a legal record of water right points of diversion. Recent and future water right transfers, new permits, ownership changes, and corrections to IDWR records may not be reflected in this list. Diversions that have not been inventoried by IDWR staff may not be shown on this list.

Water rights pertaining to each point of diversion are sorted by priority date. Note that a number of water rights have multiple points of diversion. The rate deliverable at the heading must be reduced to account for rights delivered to other PODs.

Dear Watermaster:

In compliance with and pursuant to the SRBA ORDER OF PARTIAL DECREE FOR GENERAL PROVISIONS IN ADMINISTRATIVE BASIN 34 and IDAPA Rule No. 37.03.12.040 the undersigned water right holders, each holding valid SRBA Partial Decree(s), call for the delivery of their surface water right(s) in their respective priorities and quantities to their various point(s) of diversion at the commencement of the 2004 irrigation season. If it is thought or determined that these priority calls for natural flow water rights are not deliverable to their respective point(s) of diversion at the commencement of the irrigation season, we call for the impoundment of these same water right supplies into rotation credit as described in Rule 40.02.d.iii and g. for the purpose of "charging the system" downstream from the Mackay Reservoir.

Pursuant to Administrative Rule No. 40 and by virtue of this call, we expect all upstream junior diversions which are from an administratively connected source supply to our prior rights be curtailed until such time as our water rights are fully satisfied (with the exemption of the seepage flows through the embankment of the Mackay Reservoir described in General Provision No. 2). This call also applies to any prior rights which may exist where no actual delivery call has been made pursuant to this same rule.

Incorporated in this same call we request the commencement of the irrigation season for Basin 34 not be initiated prior to the May 1st date as described in Rule 40.04 unless expected water supply forecasts or actual conditions were to change substantially.
